- To ensure Centre County Elections can process and open 40,000
 absentee and mail-in ballots, the Board of Commissioners has an
 agreement with Penn State for the use of Presidents Hall at the Penn
 Stater to be used as the Vote-By-Mail Room
- More than 200 County residents volunteered to work a shift
- Assumption is the county will have the majority of absentee/mail-in ballots processed by the time polls close at 8:00 pm
- At 8:01 pm on Election Night the information will be uploaded to the PA Dept of State's Election Result webpage and the County webpage
- Processing will continue through the evening and into Wednesday, if needed
- If mailing in ballot, follow the instructions: Complete the ballot, date and sign the ballot, enclose the ballot in the smaller security envelope then place the security envelope in the outer envelope before submitting NOTE: Do not add additional information/a message to the ballot. A hearty Thank You or similar message added to the ballot may invalidate the ballot
- Last minute submitters may go to the Bryce Jordan Center Ticket Office to request a ballot. It may be filled out and given back to the ticket agent to be counted. Voters may take the ballot they received in the mail, complete and drop it off at the Borough Building drop box

4. Borough Updates:

- Borough/Neighborhood Coalition Update:
 - Meetings were held on September 30 and October 1 to gather feedback for recommendations for Police Oversight Board
 - Katherine Oh Yeaple was appointed and sworn in October 5 to fill the seat on Council vacated by Dan Murphy
 - The Borough, PSU and other stakeholders are working to address crowd control measures for watch and tailgating parties for upcoming football games – reminder parking isn't permitted on streets from 2 am to 6 am and on lawns; greater than 10-person parties (inside/outside) is a citable offense

- B & B owners renting within the ordinance regs are not responsible for renters cited for offensive behavior and/or party size or noise violations
- PSU police officers are authorized to enforce the local COVID-19 ordinance on campus
- o Trick-or-Treating in the Borough is set for October 29, 6:00-8:00 pm
- Multiple groups are working to address the surge in COVID-19 cases in the county – PA-DOH has Centre County on its radar screen to help to contain and track the spread of the virus
- 2020 Census will remain open until October 31 current rate of return is 64.5% compared to 70.3% in 2010
- Congratulations to police officers receiving promotions and acknowledgement of their value to community health and safety
- Two-hour free parking is available downtown enforcement expected
- Citizens Oversight Board seeking resident input regarding living in the neighborhood with COVID-19 – comments being accepted on the Borough Council web site (permanent residents urged to comment) - Council will review proposals presented regarding the role and authority granted for the Board's oversight responsibilities and investigative purview – process may involve a vote to amend current charter
- E. Fairmount Avenue Park project moves forward with the continuation of brush and tree clearing, opportunity to select playground equipment forth coming (one set for children ages 2-5 and one set for older children)
